Course objectives and evaluation:

The course aims to provide students the ability to combine urbanisation process with specific social, cultural, economic and political conditions that change in the course of time. The extent of the lectures is temporarily limited with the period started with the urbanisation in Roman Empire (27BC) and terminated with the contemporary city. As its spatial extent, although at different occasions references about urbanisation process in Anatolia will be provided, the course is mainly focused on the European geography.

The course has one mid-term exam (35%) mostly based on open ended, discussion questions which test students' understanding of the course, relational analysis and critical thinking capacity. The final evaluation of the course requires submission of a research poster (group work) based on the synthesis of the course content with the weekly arranged screenings and provided literature (10%, 10%, 20%). Students will submit a "draft research poster" prior to final submission and this will be graded as well (10%).

Attendance is compulsory for this course. Students are "free" to intervene to the narration of the course as their participation to discussions is strongly recommended and graded accordingly (15%).
